Notice of Intent to Adopt a Mitigated Negative Declaration

## Interstate 40 Bridge Scour Mitigation



<p><b>WHAT'S BEING PLANNED</b></p>	<p>The California Department of Transportation (Caltrans) proposes to mitigate the scour underneath the Halfway Hills Wash Bridge on Interstate 40 (I-40) by retrofitting the north and south bridges with outrigger bents or replace the existing bridges. The lane configurations will remain the same. The project is at Post Mile (PM) R100.8/R101.8 in San Bernardino County, near Essex.</p>
<p><b>WHY THIS AD?</b></p>	<p>Caltrans has studied the effects this project may have on the environment. Our studies show it will not significantly affect the quality of the environment. The report that explains why is called an <i>Initial Study (with Proposed Mitigated Negative Declaration)</i>. This notice is to tell you of the preparation of the <i>Initial Study (with Proposed Mitigated Negative Declaration)</i> and of its availability for you to read, and to also offer the opportunity to request a public hearing or to provide comments, and the intent to adopt this Mitigated Negative Declaration.</p>
