SUBJECT: Filing of Notice of Determination pursuant to Public Resources Code section 21108

Project Title: Streambed Alteration Agreement No. 1600-2020-0254-R2 ("Celina" Timber Harvest Plan (THP) 2-20-00139-NEV), Sierra Pacific Industries.

Project Location: The projects are located within the boundaries of a timber harvesting plan in Nevada County, within CALWATER watersheds Bear Trap, Poorman Creek, South Fork Poorman Creek, Texas Creek and their connecting tributaries; Township 18N, Range 11E, Sections 10, 11, 15, 16, 25, 29, and 35 of the U.S. Geological Survey (USGS) 7.5-minute Quad Maps, Graniteville and Alleghany, Mount Diablo Base and Meridian.

Project Description: The projects are limited to upgrading an old Humboldt crossing to a vented rock-filled ford, the replacement of a failed Corrugated Metal Pipe (CMP) and the construction of two waterholes. Further explanation of this work can be referenced in THP 2-20-00139-NEV.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
