

Notice of Intent to Adopt a Mitigated Negative Declaration

Project Title: Sailing Lake Access Road Improvement Project
City/County: City of Mountain View, Santa Clara County, California
Public Review Period: December 1, 2020 to December 31, 2020

NOTICE IS HEREBY GIVEN that the City of Mountain View (City) has prepared a Draft Mitigated Negative Declaration (MND) for the **Sailing Lake Access Road Improvement Project**, which is available beginning on December 1, 2020 for review and comment by the public and all interested persons, agencies, and organizations for a period of 30 days, ending on December 31, 2020. All comments on the Draft MND must be received by that date.

Project Location: The approximate 3-acre project site consists of the Shoreline Lake Dam, at the western end of Shoreline (Sailing) Lake, and the east side of the Coast Casey Forebay. An offsite 0.25-acre contractor staging area would be temporarily located in a City-owned parking lot at the eastern end of Terminal Boulevard. The temporary contractor staging area serves as a parking area for public access to the trails in Shoreline Regional Park.

Project Description: The project would retrofit Shoreline Lake Dam (No. 7000 142, Santa Clara County) at the western end of Shoreline Regional Park to meet dam safety standards, including strengthening the embankment and mitigating seepage issues. A drained stability berm would be constructed at the downstream toe of the existing Shoreline Lake Dam, and the existing dam crest would be raised by 3.5 feet. Riprap would be placed for slope protection. Aggregate base, followed by asphalt, would be installed on top of the heightened berm crest to maintain the existing 12-foot-wide access road and to accommodate future construction access to the Coast Casey Forebay north levee for the South Bay Salt Pond Restoration Project.

Potentially Significant Environmental Effects: Potentially significant impacts in the following areas are discussed in the Mitigated Negative Declaration: Air Quality, Biological Resources, and Hazards and Hazardous Materials. Each potentially significant effect is reduced to a less-than-significant level through mitigation.

Public Review and Comment: Comments on the Draft MND must be received by December 31, 2020.
