**Project Location/Address/City/County**: The project is located just east of the town of Plumas Lake and approximately 1.6 miles southwest of the Hoffman Plumas Road and Hoffman Road intersection at Levee Mile 1.86, in Yuba County.

**Description of Nature, Purpose, and Beneficiaries of Project**: To remove and replace an existing failing 18-inch-diameter corrugated metal pipe through the left (east) bank levee of the Western Pacific Interceptor Canal with a new 18-inch-diameter steel pipe. The pipe replacement includes installation of an outfall structure with access control gate, an inlet structure with trash rack, an automatic drainage gate, rip rap, facility markers, a gate riser structure with positive closure device, and a steel walkway (5 feet long by 4 feet wide) with guardrails on the landside levee slope to facilitate maintenance of inlet structure.
