Project Title: Franklin Septic Conversion (Streambed Alteration Agreement EPIMS Notification No. SAC-50416-R2)

Project Location: The project is located at the Franklin Creek crossing of Franklin Boulevard, in the unincorporated community of Franklin, which is immediately south and west of the City of Elk Grove, in the County of Sacramento, State of California; Latitude 38.38352, Longitude - 121.45395 (WGS 84 datum, decimal degrees).

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement EPIMS Notification Number SAC-50416-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Sacramento County - Office of Planning & Environmental Review.

The project is limited to the installation of a sewer line that will cross underneath Franklin Creek. A high-density polyethylene pipeline would be installed under Franklin Creek via horizontal directional drilling.

This is to advise that CDFW, acting as a Responsible Agency, executed the above-described Streambed Alteration Agreement on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the mitigated negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was not adopted by CDFW for this project.
