This project is Use Permit for a truck stop with truck wash, gas station, and convenience store. The project includes a 13,412 square foot convenience store and gas station with a 7,200 square foot automobile fueling canopy, a 5,940 square foot diesel fueling canopy, a 3,500 square foot truck wash, and a 2,032 square foot fuel storage building, and parking for twenty-seven (27) tractor-trailers. The project proposes 30,052 square feet of total buildings at full build out. The project proposes utilizing a new on-site well, septic system, and retention pond. The project site has direct access is from Ahern Road. This parcel is not under Williamson Act contract.
