Project Description

The California Department of Transportation (Caltrans) proposes repairing and upgrading pull boxes and electrical facilities at various post miles along State Routes (SR) 4 and 99, and Interstate (I) 5 in the City of Stockton, San Joaquin County. The scope of work includes ground disturbance, trenching, replacing damaged and stolen electrical wiring, upgrading pull boxes to be tamper-resistant, and installing current standard locking mechanisms on electrical cabinets. All work will occur within Caltrans Right of Way (ROW). The purpose of this project is to restore power to existing lighting, message boards, cameras, etc. and to prevent future electrical wire damage or theft from occurring. The project is needed to ensure the functionality of Caltrans electrical facilities which help keep the traveling public safe.

General:

Cultural:

 2. Protect the discovery area
 3. Notify the Engineer
 4. The Department Investigates. Do not move cultural materials or take them from the job site. Retain a qualified archaeologist to assess the significance of the find. Do not resume work within the discovery area until authorized.
- If human remains are discovered, State Health and Safety Code Section 7050.5 states that further disturbances and activities shall cease in any area or nearby area suspected to overlie remains, and the County coroner contacted. Pursuant to Public Resources Code Section 5097.98. If the remains are thought to be Native American, the coroner will notify the Native American Heritage Commission (NAHC) who will then notify the Most Likely Descendent (MLD). At the same time the landowner will work with the MLD on the respectful treatment and disposition of the remains. Further provisions of PRC 5097.98 are to be followed as applicable.
