**Project Description:** The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement EPIMS Notification Number SIE-19150-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Truckee River Watershed Council.

The project is limited to the placement of instream structures, placement of buried log grade control structures, engineered riffles, minor grading to re-engage historic stream flow paths in Upper Lacey Meadow and Lower Lacey Meadow, and removal and replacement of undersized or non-functioning culverts with ford crossings.

This is to advise that CDFW, acting as a Responsible Agency, executed the above-described Lake and Streambed Alteration Agreement on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the  mitigated negative declaration /  negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
