The Project involves a comprehensive update to all elements of the General Plan with the exception of the Housing Element, which is not being presently updated. Preparation of the General Plan is underway, and a Draft Land Use Diagram and key policies are currently under review by the General Plan Advisory Committee (GPAC), appointed by the City Council. Significant community input has been gathered through community meetings and workshops, and online surveys. Information on work completed to date, community input gathered, along with the Draft Land Use Plan and policy proposals that are currently being worked on are available at the project website <https://napa2040.com>. The Napa General Plan Update will have all elements required by State law plus additional elements to incorporate strategies for achieving the plan vision, complying with new State law enacted since the Napa General Plan was last comprehensively updated, and addressing emerging trends and new technologies. The General Plan is anticipated to have the following elements: Land Use and Community Design; Transportation; Community Services, Parks, and Recreation; Historic Resources; Climate Change and Sustainability; Natural Resources Conservation; Safety and Noise; Public Health and Equity; and Economic Development.
