The project proposes to rezone a 1.74-acre parcel from the AL-20 (Limited Agricultural, 20-acre minimum parcel size) Zone District to the M-1 (Light Manufacturing) Zone District.

The project site is located in an area that is utilized for industrial uses, residential uses, and agricultural uses. The westerly adjacent parcel is utilized for industrial purposes, the northerly and southerly adjacent parcels are improved with single-family residences, and directly east of the site is a ponding basin and agricultural operations.

Per the provisions of Assembly Bill 52 (AB 52), participating California Native American Tribes were notified of the subject application and given the opportunity to enter into consultation with the County on the project. No participating California Native American Tribes expressed concern with the project proposal or did not respond to the notification.

NOTE: Conducting consultation early in the CEQA process allows tribal governments, lead agencies, and project proponents to discuss the level of environmental review, identify and address potential adverse impacts to tribal cultural resources, and reduce the potential for delay and conflict in the environmental review process. (See Public Resources Code section 21080.3.2.) Information may also be available from the California Native American Heritage Commission's Sacred Lands File per Public Resources Code section 5097.96 and the California Historical Resources Information System administered by the California Office of Historic Preservation. Please also note that Public Resources Code section 21082.3(c) contains provisions specific to confidentiality.



**I. AESTHETICS**
