Project Title: Adelanto Switching Station Expansion Project (California Endangered Species Act Incidental Take Permit No. 2081-2021-044-06-01 Minor Amendment (ITP))

Project Location (include county): The Adelanto Switching Station Expansion Project (Project) is located within a 315-acre fenced property (Assessor's Parcel Numbers: 312810120, 312806107, 312806108, and 312805114) within the City of Adelanto, San Bernardino County. The Project is located approximately 350 feet south of Rancho Road, bounded by Raccoon Avenue to the west, Pansy Road to the south, and Daisy Road to the east, in the City of Adelanto, San Bernardino County. Interstate 15 (I-15) is approximately eight miles to the east of the Project site, United States Highway 395 (US-395) is approximately 1.5 miles to the east and State Route 18 (SR-18) is approximately 3.5 miles to the south.

Project Description: This proposed project involves the development of a 52-acre expansion within the existing Adelanto Switching Station site. The minor amendment- 01 extends the mitigation obligation deadline from 18 months to 42 months.

The Project will result in impacts to acres of western Joshua tree (*Yucca brevifolia*) habitat; the Project will permanently remove 74.33 acres of western Joshua tree habitat. The project is expected to result in incidental take of western Joshua tree, which is designated as a candidate threatened species under the California Endangered Species Act. The ITP referenced above as issued by CDFW authorizes incidental take of species listed under CESA that may occur as a result of Project implementation.
