LOCATION: Mehlert Street from 10th Avenue to 500' east of 14th Avenue (City Limits)

DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT: The project will reconstruct the road from 10th Avenue to the City Limits (500' east of 14th Ave), reconstruct ramps on the south and north side of 12th Avenue and the north side of 14th Avenue. Reconstruction includes the grind in place existing asphalt concrete pavement, grade and compact subgrade, grade and compact asphalt grindings, pave new hot mix asphalt layer, adjust existing manholes and water valve frames and covers to finish grade, and install pavement striping.

The project will construct roadway improvements including the reconstruction of the street and the reconstruction ramps on the north and south side of 12th Avenue and the north side of 14th Avenue. The existing condition of the project area is an existing two-lane damaged road with pedestrian path, and no ramps on the north side of 12th Avenue and ramps out of current City Standards on north of 14th Avenue. This project will enhance the area and improve safety for the residents of Kingsburg.

9. Surrounding land uses and environmental setting: Briefly describe the project's surroundings:

The project is located in a fully developed residential area of Kingsburg.

10.
