NOTICE OF AVAILABILITY (NOA)/NOTICE OF INTENT (NOI) TO ADOPT AN INITIAL STUDY/MITIGATED NEGATIVE DECLARATION COTTAGE CREEK MICROWAVE TOWER INSTALLATION PROJECT

In accordance with the California Environmental Quality Act (CEQA) and the CEQA Guidelines, YWA prepared a Draft Initial Study/Mitigated Negative Declaration (IS/MND) that identifies and evaluates the environmental impacts of the Cottage Creek Microwave Tower Installation Project.

Project Title: Cottage Creek Microwave Tower Installation Project

Project Location: The Proposed Project is located in northeastern Yuba County, approximately 30 miles northeast of Yuba City, at an approximate elevation of 2,000 feet. The Proposed Project area is comprised of two separate locations, the telecommunications tower site and the passive repeater site. The telecommunications tower site is located northwest of New Bullards Bar Dam and the passive repeater site southeast of New Bullards Bar Dam.

Project Description: The Proposed Project consists of constructing a telecommunication site in the north corner of the Cottage Creek Water Treatment Plant laydown yard and a passive repeater approximately three quarters of a mile from this telecommunications site. In addition, Yuba County Water Agency (YCWA) also proposes to retrofit the electrical infrastructure at the telecommunications tower and water treatment plant site and combine the multiple power feeds into one service under one meter.
