The applicant is proposing to enter into a DA and develop a 40-acre parcel into a facility containing mixed-light cannabis cultivation, nursery, and flower greenhouses, and associated operational components, such as storage structures, office space, and a restroom. The project would involve demolition of two 1-acre outdoor cultivation facilities on the site. Additional project features include new septic systems with leach fields and drainage basins for runoff, future solar-panel fields for sustainable energy, and new water wells for potable, irrigation and fire protection.
