The California Department of Transportation (Caltrans) issued a Director's Order to repair a sinkhole in the roadway in Butte County on Route 162 at postmile 3.64. The scope is as follows: remove and replace the existing culvert, de-water the area, remove and replace existing headwalls, traffic control and shoring. This project is needed to prevent or mitigate the loss or impairment of life, health, property and essential public services. Work occurred within the Caltrans right-of-way. No disposal required. No consultation or coordination required. No permits required.
