Dear Stakeholder –

Thank you for your interest in the Alpine County Park. Alpine Community Park will be on the agenda for the November 8, 2023 County Board of Supervisors meeting. Materials for the hearing have now been posted on our website here [Alpine Community Park \(sdpc.org\)](https://www.sdpc.org) for review prior to the Board meeting. Please note that as described in the Board Letter for this item, the Alpine County Park is planned to be constructed in phases with Phase 1 moving forward at this time. Phase 1 is planned to include the following components: main entrance to the park, a dog park, playgrounds, picnic areas, an equestrian staging area, a community garden, sports courts, park office and restrooms, a volunteer pad, and parking. Future phases of the project, which are not funded at this time, will include: a multi-purpose grass area, baseball field, all-wheel area, bike skills course, fitness stations, multi-purpose building, a second restroom, and additional trails and parking.

- Attend the meeting in person:
 - Board meetings are held in the Board Chamber (Room 310) of the County Administration Center, 1600 Pacific Highway, San Diego, CA 92101.
 - If you want to speak at the meeting, you need to fill out a Request to Speak form. Forms are available outside Room 310 and in the Chamber. Write in the information and give it to the Deputy Clerk. You will need a form for each item you want to speak on.
 - You need to turn in the form before public comment on that item begins. You can only turn in a form for yourself to speak. You cannot turn in a form for someone else.
 - The Clerk of the Board will call your name when it is your turn to speak. You will have two minutes. You cannot give your time to someone else.
 - You can also use your Request to Speak form to write an opinion and not speak.
