Project Title: Pomona Avenue Bridge Replacement Project (Streambed Alteration Agreement EPIMS Notification No. BUT-34822-R2 Amendment 1)

Project Location: The Project is located where Pomona Ave. crosses Little Chico Creek, in the City of Chico, County of Butte, State of California.

Project Description: The California Department of Fish and Wildlife (CDFW) has amended Streambed Alteration Agreement EPIMS Notification Number BUT-34822-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, City of Chico as represented by Tracy Bettencourt.

The amendment consists of extending the work period to June 1 to October 31 and providing the option to purchase mitigation bank credits with a financial security to satisfy compensatory mitigation requirements for permanent impacts at a future date.

This is to advise that CDFW, acting as a Responsible Agency, amended the above-described to the Lake and Streambed Alteration Agreement on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the mitigated negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was not adopted by CDFW for this project.
5. A statement of overriding considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to California Code of Regulations section 15091.
