The California Department of Transportation (Caltrans) issued a District Director's Order to repair damaged roadway located on State Route 162 in Glenn County from postmile (PM) 66.0 to PM 66.8. The scope is as follows: removing the worst of the failed pavement sections by cold planing and then paving back with Hot Mix Asphalt (HMA) Type A, striping, traffic control, and incidental work. Use of these highways is vital for regional commercial and recreational vehicular traffic. The project is needed to avoid the failure or threat of failure to the transportation system and to prevent or mitigate the loss or impairment of life, health, property and essential public services. Work occurred within Caltrans right-of-way. No excavation disposal required. No consultation or coordination required. No permits required.
