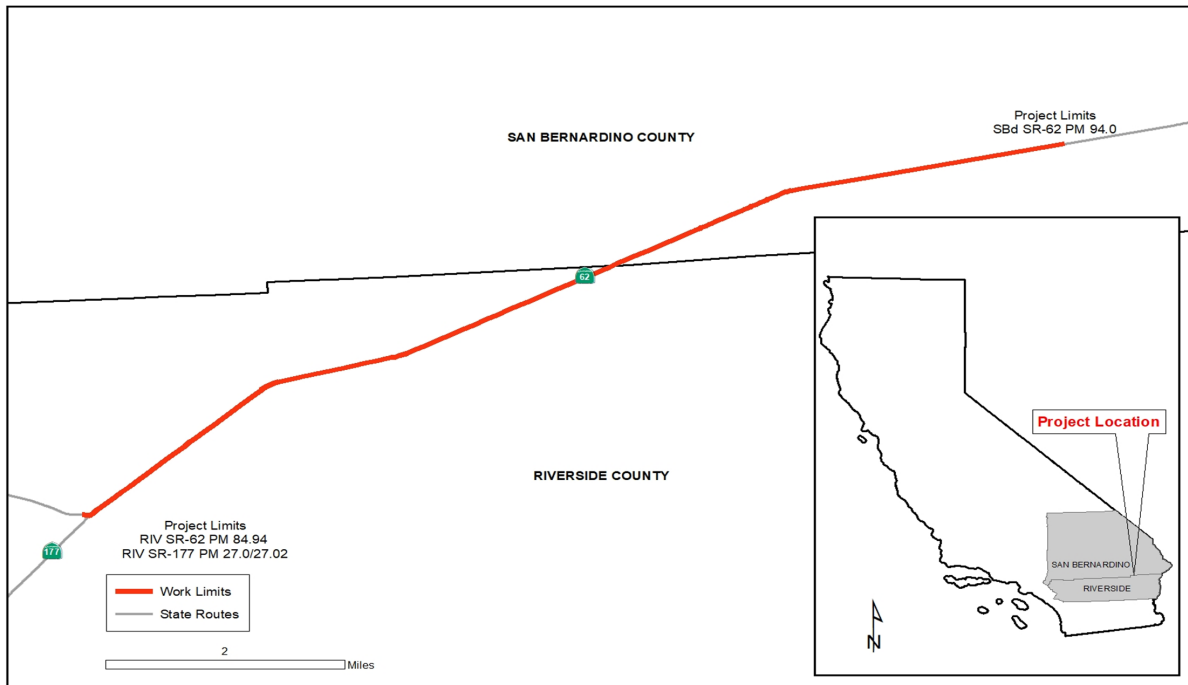


PUBLIC NOTICE

Notice of Intent to Adopt a Mitigated Negative Declaration State Route 62/177 Road Rehabilitation/Asphalt Concrete Overlay



<p>WHAT'S BEING PLANNED?</p>	<p>The California Department of Transportation (Caltrans) proposes to grind and recycle the existing asphalt and place 0.15 ft Rubberized Hot Mix Asphalt (RHMA) overlay on the entire width of pavement within the project limits. Additionally, Caltrans proposes shoulder backing and provide pavement edge treatment. Shoulder backing and associated activities would not extend beyond the existing disturbed shoulder.</p>
<p>WHY THIS NOTICE?</p>	<p>Caltrans studied the effects this project may have on the environment. Our studies show the proposed project will not significantly affect the quality of the environment. The report that explains the effects of the project is called a <i>Draft Initial Study (IS)</i>. This notice is to advise you of the preparation of the <i>Initial Study with Proposed Mitigated Negative Declaration (MND)</i> and of its availability for you to read, and to offer the opportunity to request a public hearing or to provide comments, and the intent to adopt this MND.</p>
