The Proposed Project proposes to develop an aquatic center to replace the existing indoor pool at Woodrow Wilson High School, and provide a regulation size pool for water polo games or swim meets. Construction of the Proposed Project's main facilities will include an outdoor swimming pool, bleachers, locker rooms/offices, restrooms, showers, stadium lights, LED scoreboard, parking stalls, wall enclosures, surveillance cameras, and an equipment storage enclosure/room. The Proposed Project will be in use routinely with exception of a few days in the year, as well as accommodating outside group activities that do not conflict with the needs of the school water polo and swim teams.
