DESCRIPTION OF NATURE, PURPOSE AND BENEFICIARIES OF THE PROJECT:

The proposed project is a request for a Use Permit modification to the existing Hessel Church Use Permit File No. UPE98-0114 to expand existing facilities by adding a +/- 5000 square foot pavilion over the existing outdoor patio for use of outdoor assemblies, with no changes to existing operations, including number of employees, services or visitors, located on an 8.5-acre parcel.

Categorical Exemption Section 15311 Accessory Structures.


REASON WHY THIS PROJECT IS EXEMPT:

The proposed project is categorically exempt from the provisions of the CEQA Guidelines pursuant to the Provisions of Title 14 of the California Administrative Code, Section 15311 Accessory Structures which provides for construction, or placement of minor structures, such as a pavilion, accessory to (appurtenant to) existing institutional facilities, such as a church.

No exceptions listed under Section 15300.2 apply. There is no reasonable possibility that the project would have a significant effect on the environment.
