The California Department of Transportation (Caltrans) issued a Director's Order to repair building damage at the Caltrans Yuba City Construction Field Office in Sutter County, on Route 20, at postmile 16.71. The scope of work is as follows: stucco, siding, roofing, windows, doors, lighting, interior walls, interior panels, flooring, carpet, HVAC equipment and ducting, exterior and interior painting, and incidental work. In addition, security upgrades including installation of an automatic gate, fencing, and security cameras. The Yuba City Construction Field Office performs critical functions including housing construction staff that administers and supervises construction contracts and other essential services. This project is needed to prevent and mitigate the loss or impairment of life, health, property, and essential public services. (Continued on page 3)
