Project Title: Streambed Alteration Agreement No. 1600-2021-0002-R2, "Blue Yonder" Timber Harvest Plan (THP) 2-20-00196-PLA

Project Location: The projects are located within the boundaries of a THP within watersheds Fulda Creek, Texas Hill, and Lake Putt in Placer County, State of California. The projects are located on the Westville, Blue Canyon and Cisco Grove U.S. Geological Survey (USGS) map, Township 16N, Range 11E, Sections 2, 23, 27 and Range 12E, Sections 11, 17, and 19, Mount Diablo Base and Meridian.

Project Description: The projects are limited to the installation of a vented rock ford with a temporary pipe, the expansion of an existing instream water drafting pool, and a new water drafting location and approach. Further information can be found in THP 2-20-00196-PLA.
