Notice of Intent to Adopt a Mitigated Negative Declaration and Notice of a Public Hearing

Project Title: Bay Village Planned Development
Ten Lot Residential Subdivision

Project Location: Erba Lane (no situs - vacant), Scotts Valley, CA, 95066
APN 022-481-18 and 22

Description of Project: Project proposes to subdivide an existing 1.04-acre site into ten lots and two common parcels, and construct six single family homes and four duet-style single family homes (10 units total). Project requires a Mitigated Negative Declaration, Planned Development, Subdivision and Design Review. The Planning Commission will hold a public hearing, review the application, hear public comment, and make a recommendation to the City Council for final action at a future public hearing to be scheduled.

Any challenge in court must be commenced within ninety (90) days of the decision, as required by section 1094.6 of the California Code of Civil Procedure.
