Request for a Use Permit to allow the operation of an animal sanctuary for rescued hens to be put up for adoption on an 11.92-acre parcel. Proposal includes the construction of three new 288 sq. ft. barns, and visiting hours for the public. The site will be open to the public by reservation only, once a week on Saturdays from 11:00 a.m. to 4:00 p.m. The site will generally be open to receive up to 20 attendees, and four times a year it will host educational classes about animal care and behavior for up to 100 attendees.
