Present Land Use/Zoning/General Plan Designation:
General Plan: City of Orange is designated OS-P (Open Space Park). The southern portion of the Project Site, located in the City of Tustin, is designated PCR (Planned Community Residential). Zoning: City of Orange as R-O (Residential Open Space). The southern portion of the Project Site, located in the City of Tustin, is designated R-O (Residential Open Space).

Project Description: *(please use a separate page if necessary)*

The Project would construct a new shared-use Class I path along the west side of Jamboree Road and buffered (striped) Class II lane along Pioneer Road and would extend the Peters Canyon Bikeway Trail to the existing bikeway at the intersections of Jamboree Road with Canyon View Avenue and Pioneer Road with Pioneer Way in the cities of Orange and Tustin. The Project would also include intersection improvements (reconstruction of existing curb ramp and inclusion of way finding signage) at Jamboree Road and Pioneer Road to connect the proposed Class II buffered bike lanes to the existing trails on the south, and to the proposed Class I shared-use path to the existing Class I path on the north, along the west side of Jamboree Road. In addition, the Project would also include sidewalk improvements, the relocation of utilities, construction of a retaining wall, signage and striping improvements, and landscaping improvements. The Proposed Project closes a critical gap in the County's existing bikeway network, which will enhance bicyclists' safety and comfort.
