UC Merced proposes to develop a new academic building, including a site access road and parking lot, in the southeastern portion of the existing campus adjacent to Cottonwood Meadow. The building would house the Campus' Health and Behavioral Sciences-Medical Education (HBS-ME) programs. In addition, UC Merced plans to modify the existing Cottonwood Meadow storm water detention basins to accommodate the siting of the proposed building and to provide detention capacity for storm water runoff generated by the proposed building, parking lot, and other improvements.
