**PROJECT TITLE:** Annual Fee Land Fire Abatement Mowing

**PROJECT DESCRIPTION:** The Sonoma County Agricultural Preservation and Open Space District (District) is conducting springtime fire abatement mowing on the following District-owned properties: Calabazas Creek Open Space Preserve, Dogbane Preserve, Haroutunian North, Haroutunian South, Oken, Paulin Creek Preserve, Saddle Mountain Open Space Preserve, and Young-Armos. The purpose of this project is to reduce the fire risk of excessive vegetative growth on District-owned properties. The work involves conducting bird-nesting surveys, identifying any sensitive areas to avoid, and mowing and/or weed-whipping limited portions of each property.
