A bridge preservation project on ten bridges from the Moulton Pkwy UC (Laguna Niguel) to the Bristol St. UC (Costa Mesa). The bridge decks and approach and departure slabs are exhibiting signs of wear (e.g. cracking and settlement). The project intends to maintain bridge health and extend its service life while providing a safe and stable riding surface. The scope of work consists of applying methacrylate on bridge decks, replacing joint seals, patching spalls, and installing and replacing approach and departure slabs. The total disturbed surface area (DSA) will be less than one acre. The project will occur within the State right-of-way. The project will be funded by State and federal sources.
