Project Description: The proposed project consists of repair of approximately 13,867 feet of 24-, 27-, 30-, 51-, and 54-inch diameter sewer using cure-in-place pipe lining; approximately thirteen (13) feet of top encasement, construction of three (3) new manholes, and rehabilitation of twenty eight (28) manholes.



This is to advise that the Board of Directors of the Sanitation District No. 18 has approved the Project described above at its Board meeting on June 23, 2021 and has made the following determinations regarding the Project:

1. The Project, with the incorporation of mitigation measures, will not result in a significant effect on the environment.
2. A Final Initial Study/Mitigated Negative Declaration (IS/MND) dated June 7, 2021, which reflects the independent judgment and analysis of the District, was prepared for this Project in accordance with the terms, provisions and requirements of the California Environmental Quality Act (CEQA) and related CEQA Guidelines.
3. A Mitigation Monitoring and Reporting Program (MMRP), dated June 7, 2021, was adopted for the Project and the required mitigation measures were made a condition of the approval of the Project.
4. A Statement of Overriding Considerations is not required and was not adopted for the Project.
5. Findings were made pursuant to the provisions of CEQA.
