



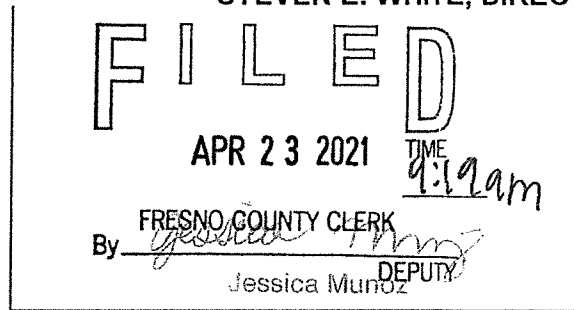

DESCRIPTION OF PROJECT: The project proposes to amend the County Service Area (CSA) No. 32 Sphere of Influence (SOI) and annex into CSA 32 all properties now receiving or planned to receive service from CSA 32. The SOI will expand from 63.09 acres to 97.16 acres in size.

REASONS WHY THE PROJECT IS EXEMPT: The subject application proposes to expand the sphere of influence (SOI) of a County Service Area (CSA) and annex properties under the expanded SOI to provide services to the annexed properties. There is no construction or expansion of facilities proposed, therefore no impact to historical or cultural resources will occur. There is no listed hazardous waste/material facility located in vicinity of the project site. The project site is not located in a special flood hazard area. There is no expansion of CSA facilities involved with this project that would generate transportation, air quality, or greenhouse gas emission impacts.

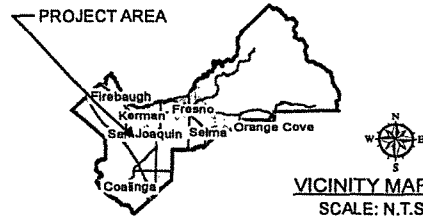
