Project Title: Narrows 2 Debris Removal Project (Lake Alteration Agreement EPIMS Notification No. YUB-19673-R2)

Project Location (include county): The project is located at the Narrows 2 Intake Structure in the Harry L. Engelbright Lake, in the County of Yuba, State of California; Latitude 39.240714°, Longitude -121.270413°; Assessor's Parcel Number (APN) 005-300-010-000.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement EPIMS Notification Number YUB-19673-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Yuba County Water Agency as represented by Jacob Vander Meulen.

The project consists of the removal of approximately 175 cubic yards of woody debris from the intake of the Narrows 2 Powerhouse. The debris will be dried and burned onsite or transferred to an offsite landfill.

This is to advise that CDFW, acting as a Responsible Agency, executed the above Lake and Streambed Alteration Agreement on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was / was not adopted by CDFW for this project.
