Cady Ranch Water Distribution Project Notice of Availability of Initial Study Notice of Intent to Adopt a Mitigated Negative Declaration

WHAT IS BEING PLANNED?

Fowler Brothers Farming, Inc., in cooperation with the Stockton East Water District (District), is proposing to install a new surface water diversion in order to utilize surface water for irrigation purposes on the Cady Ranch property. The Project will consist of two new pumps off of the Calaveras River, a new reservoir, and approximately 4,900 feet of 27" diameter PVC pipe for the conveyance of surface water. The District has prepared an Initial Study with Proposed Mitigated Negative Declaration which examines potential environmental impacts caused by the proposed Project.

WHY THIS PUBLIC NOTICE?

The District has studied the effects this Project may have on the environment. The studies within the Initial Study with Proposed Mitigated Negative Declaration show it would not significantly affect the quality of the environment. This notice is to advise you that the preparation of this report has been completed and is available for you to review.
