Project Description (Proposed actions, location, and/or consequences).

The proposed project would accommodate a cannabis cultivation, manufacturing, processing, testing, and distribution center on an undeveloped 3.8-acre site. The project would include a lot line adjustment to combine two legal lots into one. The building would be approximately 19,000 square feet and two-stories (35 feet in height) with screening for rooftop mechanical equipment up to 44 feet in height. The project would require up to 65 full-time employees and 15 part-time employees at peak periods. The facility would only sell cannabis products to State licensed facilities on a wholesale basis and there would be no retail sales on-site. As such, the proposed industrial cannabis facility would not be open to the public and visitors would be permitted only when escorted and for a specific business purpose.

Identify the project's significant or potentially significant effects and briefly describe any proposed mitigation measures that would reduce or avoid that effect.

The project would result in potential air quality impacts, which would be mitigated to a less than significant level through implementation of Mitigation Measures AQ-1 and AQ-2 (odor abatement plan and control measures). The project would result in potential impacts to passerine bird species nesting on-site, which would be mitigated to a less than significant level through implementation of Mitigation Measure BIO-1 (nesting bird avoidance and minimization efforts). The project would result in potential impacts due to greenhouse gas emissions, which would be mitigated to a less than significant level through implementation of Mitigation Measure GHG-1 (emissions reduction plan). The project would result in potential impacts to water quality, which would be mitigated to a less than significant level through implementation of Mitigation Measure HWQ-1 (discharge requirements).

If applicable, describe any of the project's areas of controversy known to the Lead Agency, including issues raised by agencies and the public.

No public agencies have raised issues of controversy beyond the potentially significant impact and associated mitigation measures identified in the IS-MND. The City did not received any requests for consultation from any of the groups listed on the NAHC's Tribal Consultation regarding the proposed project. Community members of the nearby neighborhood development have voiced concerns regarding potential odors emitted by the facility.
