Project Title: 55555 Amargosa Streambed Alteration Agreement No. EPIMS-SBR-30784-R6

Project Location (San Bernardino): 55555 Amargosa is located at Assessor's Parcel Number 0405-062-51-0000 in the city of Hesperia in San Bernardino County, State of CA.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement (EPIMS- SBR-30784-R6), pursuant to Fish and Game Code section 1602, to the project Applicant, 55555 Amargosa LLC.

The project is limited to the grading of an existing earthen channel to remove debris and improve hydraulic characteristics from the south property line to the north property line maintaining existing flow path and depth. The project will cover 0.25 acres of ephemeral desert streambed.

This is to advise that CDFW, acting as a Responsible Agency, approved the project described above on November 17, 2022 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the **Mitigated Negative Declaration** prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures **were** made a condition of CDFW's approval of the project.
4. A Mitigation Reporting or Monitoring Plan **was** adopted by CDFW for this project.
5. A Statement of Overriding Considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to California Code of Regulations section 15091.
