The Proposed Project would involve the construction of a 109-acre industrial park consisting of 57 condo lots that will accommodate a combination of general light industrial, cannabis (cultivation, manufacturing, distribution, etc.), and large-scale energy/utility facilities land uses on approximately 109 acres. The proposed project will include 236,180 square feet of general light industrial uses, 761,770 square feet of industrial park (cannabis activity), and 286,230 square feet for large-scale energy/utility uses (power and reclamation facility) for a total of 1,284,180 square feet on approximately 29.48 acres.
