Project Title: Dogwood Timber Harvest Plan 1-15-042 SON "Dogwood" (Lake or Streambed Alteration Agreement No. 1600-2021-0012-R3)

Project Location (include county): The project is located in Sonoma County, approximately 0.5 miles E of Gualala; Sections 4, 5, 6, 8, 15, 16, 17, 21, 22, 25, 26, 27, 30, 31, 33, and 35, Townships 10N and 11N, Ranges 14W and 15W, U.S. Geological Survey (USGS) maps Gualala 1977, Stewarts Point 1978, and McGuire Ridge 1991; Mt. Diablo base and meridian.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number 1600-2021-0012-R3, pursuant to section 1602 of the Fish and Game Code to the project Applicant, John Bennett.

The project is limited to installation of four temporary bridges, water drafting at four gravel bar water drafting sites and three off-site water holes, installation of a temporary pipe at three temporary skid trail watercourse crossings, installation of two temporary road watercourse crossings, installation of one temporary culvert, installation of one permanent culvert or rocked ford, and stabilization of one watercourse crossing

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on May 24, 2021 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will / will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
