

Notice is hereby given that the County of Fresno has prepared Initial Study Application (IS) No. 7940 pursuant to the requirements of the California Environmental Quality Act for the following proposed project:

INITIAL STUDY APPLICATION NO. 7940 and **PCOC** (*Pre-Application for Certificate of Compliance*) **APPLICATION NO. 3529** filed by **DAVID BRINKLEY**, proposing to create a 1.5-acre gift-deed parcel from an existing 32.96-acre parcel located in the AE-20 (Exclusive Agricultural, 20-acre minimum parcel size) Zone District. The subject property is located at the northeast corner of Shain Avenue and Evans Avenue, approximately eight miles northwest of the nearest city limits of the City of Firebaugh (Sup. Dist.: 1) (APN: 001-280-14). Adopt the Negative Declaration prepared for Initial Study Application No. 7940 and take action on PCOC (*Pre-Application for Certificate of Compliance*) Application No. 3529 with Findings and Conditions.
