The Project consists of a Class I path from Oceanside Boulevard to Morse Street, spanning the Loma Alta Creek and running adjacent to the City of Oceanside La Salina Waste Water Treatment Plant and Buccaneer Park. A 255-foot long, two-span cast-in-place concrete deck has been chosen as the preferred bridge type. The Project closes the remaining gap of the Coastal Rail Trail, as well as provides connectivity to Buccaneer Park, and a connection to a future parking lot planned north of Loma Alta Creek, adjacent to the wastewater treatment plant.
