Project Title: Y Knot Timber Harvest Plan No. 4-20-00185/TUO (Streambed Alteration Agreement No. 1600-2020-0203-R4)

Project Location (include county): The Project location occurs in Township 5 N, Range 16 E, Sections 11, 12, 16 and 17; Township 5 N, Range 17 E, Sections 4, 5, 6 and 7; Township 6 N, Range 17 E, Sections 32 and 33; in the Boards Crossing and Liberty Hill USGS 7.5 minute quadrangles; east of Highway 4 between Griswold Creek and Crane Creek, in Tuolumne County.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement number 1600-2020-0203-R4, pursuant to section 1611 of the Fish and Game Code to the project Applicant, Sierra Pacific Industries. Project activities include reconstruction of a rocked ford/dip, culvert replacement, permanent crossings, temporary crossings, and operations and other activities at water drafting sites, related to the Y Knot Timber Harvest Plan in Tuolumne County, No. 4-20-00185/TUO.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on 6/7/2021 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the Timber Harvest Plan prepared by the Lead Agency for this project pursuant to Z'berg-Nejedly Forest Practice Act and the California Forest Practice Rules, a CEQA-equivalent California Certified Regulatory Program.
3. Mitigation measures were made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was adopted by CDFW for this project.
5. A statement of overriding considerations was not adopted by CDFW for this project.
6. Findings were made by CDFW pursuant to the Provisions of CEQA.
