
Project Description: Two industrial/warehouse buildings totaling 1,850,000 square feet and associated improvements, including loading docks, tractor-trailer stalls, passenger vehicle parking spaces, stormwater detention basins, and landscaping. Off-site improvements include street improvements along the Project frontage along Sultana Street, Mesa Linda, and Cataba Road, and U.S. Highway 395. Off-site improvements also include installation of new and upsizing of existing domestic water lines, storm drain lines, and sewer lines in the Project vicinity.

This is to advise that on January 17, 2023, the City of Hesperia, acting as Lead Agency, (i) approved Conditional Use Permits 21-00004 and 21-00005 and Tentative Parcel Map 22-00010 to implement the Project, and (ii) introduced for first reading Ordinances 2023-03 and 2023-04, pertaining to Specific Plan Amendment (SPLA) 21-00001 and Development Agreement 22-00002.

On February 7, 2023, The City of Hesperia approved the second reading of Ordinances 2023-03 and 2023-04, pertaining to Specific Plan Amendment (SPLA) 21-00001 and Development Agreement 22-00002. The City of Hesperia has made the following determinations regarding the above described Project.

1. The Project will have a significant effect on the environment.
2. An Environmental Impact Report was prepared for this Project pursuant to the provisions of CEQA.
3. Mitigation measures were made a condition of approval of the Project.
4. A mitigation reporting or monitoring plan was adopted for this Project.
5. A statement of Overriding Considerations was adopted for this Project.
