The adoption and implementation of the LHMP and Safety Element would not involve any changes in land use or development entitlements and would not lead directly to any activities that would cause any physical change in the environment. While the LHMP and Safety Element do identify actions that would involve construction of improvements that would reduce Cloverdale's vulnerability to hazards, these projects would be subject to separate environmental review once the City secures funding for their design and implementation.
