The County of San Luis Obispo Public Works Department proposes to construct a multi-use recreational trail, the Templeton to Atascadero Connector Project, on the east side of Highway 101 and west of the Union Pacific Railroad (UPRR) tracks between Templeton and Atascadero. The trail would be approx. 1 mile long and would extend from the east side of South Main Street in Templeton to the existing sidewalk at San Ramon Road in Atascadero, with span bridges over Paso Robles and Graves Creeks.
