NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

NOTICE IS HERE GIVEN that, as lead agency under California Environmental Quality Act (CEQA), the Solano Resource Conservation District (Solano RCD): 1) Has concluded that, after preparing an Initial Study, the Ulatis Creek Habitat Restoration Project (Project) would not have a significant effect on the environment with the implementation of mitigation measures described in the Initial Study; 2) Has prepared a proposed Mitigated Negative Declaration (MND) for the Project; and 3) Anticipates recommending to the Solano RCD Board of Directors that it adopt the MND.

PROJECT TITLE: Ulatis Creek Habitat Restoration Project

LOCATION: The project is located along the north bank of Ulatis Creek just west of the confluence of Ulatis Creek with Cache Slough in the Cache Slough Complex in Solano County. It occurs about 7.5 miles north of Highway 12 and 3 miles east of Highway 113 between latitudes of 38.298108° and 38.291074° and between longitudes of -121.780314° and -121.749141°.

BRIEF DESCRIPTION: The purpose of this project is to restore 20 acres of riparian woodland to the north bank of Ulatis Creek, improving the ecological function of the area for the benefit of native plant and wildlife species. The project will result in the installation of 1,880 native trees and shrubs, 25,000 native forb and sedge plugs and 100 pounds of native wildflower seed, while several species of invasive weeds will be controlled throughout the site.
