The applicant proposes to construct a new dairy on approximately 220 acres of existing cropland to house 28,000 total animals. The proposed project would include construction of 2,660,900 sq. ft. of animal housing and farm buildings, 1,145,365 sq. ft. of impervious production area, and 4,350,000 sq. ft. of earthen production area. 220 acres of irrigated cropland would be converted to active dairy facilities.
