DESCRIPTION OF NATURE, PURPOSE, AND BENEFICIARIES OF PROJECT:

The scope of this project consists of various pipe work in the vicinity of the Sunset Blvd & Stone Canyon Rd intersection. Pipe work includes:

- Remove and Replace: 1,430 linear feet along the same alignment with same size and/or upsize
- New Pipe Installation: 300 linear feet along a new alignment
- Abandon: 930 linear feet
- Remove Only: 350 linear feet

In addition, 6 isolation valves and a regulator valve will be installed. The regulator valve will be installed in an existing vault for Sunset & Stone Canyon RS to replace an existing cone valve.


EXEMPT STATUS:
 Categorical Exemption Section 15301, Class 1 (Existing Facilities); Section 15302, Class 2 (Replacement or Reconstruction)
 Statutory Exemption Section 15282(k)

JUSTIFICATION FOR PROJECT EXEMPTION:
 In accordance with the California Environmental Quality Act, this project is Categorically Exempt from CEQA review pursuant to section 15301 (Existing Facilities) and 15302 (Replacement or Reconstruction). Section 15301, Class 1 consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of the existing or former use. Section 15302, Class 2 consists of replacement or reconstruction of existing structures and facilities where the new structure will be located on the same site as the structure replaced and will have substantially the same purpose and capacity as the structure replaced, including the replacement or reconstruction of existing utility systems/facilities involving negligible or no expansion of capacity. Statutory Exemption Section 15282(k) provides for the installation of new pipeline or maintenance, repair, restoration, removal, or demolition of an existing pipeline as set forth in Section 21080.21 of the Public Resources Code, as long as the project does not exceed one mile in length. The proposal for the Stone Canyon & Sunset West Trunk Line (Unit 1 Phase 2) Replacement Project meets the requirements of these exemptions; therefore, no further CEQA review is required.
