

**NOTICE OF AVAILABILITY AND INTENT TO
ADOPT A MITIGATED NEGATIVE DECLARATION BY THE
MOUNTAIN GATE COMMUNITY SERVICES DISTRICT**

NOTICE IS HEREBY GIVEN that the Mountain Gate Community Services District (MGCS D) has prepared an Initial Study and proposed Mitigated Negative Declaration (IS/MND) pursuant to the California Environmental Quality Act (CEQA), for the project described herein. The MGCS D Board of Directors will consider adopting the MND at their regularly scheduled meeting of **Wednesday, September 8, 2021**, with the session commencing at **6:00 PM**, or as soon thereafter as possible, at the MGCS D offices located at 14508 Wonderland Blvd., Redding, CA 96003.

Project Applicant: Mountain Gate Community Services District

Project Title: Water System Improvements Project

Project Location: The project is located within the unincorporated community of Mountain Gate in Shasta County, generally south/southeast of Lake Shasta and north and east of the City of Shasta Lake. Improvements on the west side of I-5 would occur at the MGCS D Corporation Yard, 7000 Wonderland Blvd. Improvements on the east side of I-5 would occur in the public road rights-of-way (ROW) of Old Oregon Trail North, Old Oregon Trail, Copper Canyon Rd., Grande Vista Ln., Lazy J Ln., Welbula Dr., El Teda Ln., Casa Dr., and Sunrise Dr., and on the MGCS D South Water Tank site. Some of the waterline improvements would occur in public utility easements on private property.

Project Description: The proposed project includes improvements to the Mountain Gate Community Services District's (MGCS D) water system. Improvements include replacing/upsizing existing water mains and associated water services, installing a new water main, installing/replacing fire hydrants, replacing/installing Pressure Reducing Valve stations and associated solar panels, and installing a new emergency intertie. The purpose of the proposed project is to replace aging infrastructure, achieve adequate fire flows, and ensure a safe and reliable potable water supply for customers in the MGCS D's water service area.
