Description of Nature, Purpose and Beneficiaries of Project:

DWR staff will clear debris from culverts along the SBA. Removed material will be pushed into the ditch and spread by grader. The grader will shape the ditch to original specifications. Culvert cleaning will be injecting raw water at pressure from the upstream side to mimic natural runoff and flow as designed. Prior to culvert cleaning, a biological monitor will inspect the culvert to ensure there are no incidental impacts to sensitive species and/or habitats. Equipment staging overnight shall be at Dyer Reservoir or Patterson Yard. Daily staging will be on existing roadways. All work will be within DWR right-of-way.
