Request to divide one existing 80-acre parcel into four separate parcels located at 7200 Bennett Valley Road, in Santa Rosa, California. The proposed four-parcel subdivision would consist of the following: parcel 1 at 10.16 acres, parcel 2 at 10.36 acres, parcel 3 at 10.77 acres, and parcel 4 at 49.09 acres. The proposed improvements associated with the project and future anticipated residential construction could cover an area up to approximately 71,705 square feet. The project construction would include earthwork, grading, paving, construction of two clear-span bridges, and installation of utilities.
