**SUBJECT: Filing of Notice of Determination pursuant to Public Resources Code section 21108**

Project Title: Streambed Alteration Agreement No. 1600-2021-0013-R2, "Jensen" Timber Harvest Plan (THP) 2-19-00104-YUB.

Project Location: The project is located within the boundaries of a timber harvesting plan in Yuba County, within CALWATER watershed Dobbins Creek on an unnamed class II tributary of Dobbins Creek; Township 18 N, Range 7 E, Sections 28 of U.S. Geological Survey (USGS) Challenge Quad Map; Mount Diablo Base and Meridian.

Project Description: The project is limited to the placement of a new 24 inch x 20 foot long Corrugated Metal Pipe (CMP) and associated rock fill within the proposed vented ford location. Further information can be found in THP 2-19-00104-YUB.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):
